

ALLANDALE SCHOOL ENROLMENT SCHEME

October 2010



Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

The home zone will be:

All of Arawa Rd from the Valley Road intersection to the Bridge Street roundabout including Tetahi Street, Poto Street, Cutler Crescent and Howat Place.

Awatapu Drive up to the intersection with Farnworth Crescent (ie nearest the reserve) including Cleary Avenue, Farnworth Crescent, Wikepa Place, Gadd Place and Watarawi Place following the western side of the reserve through to the river's edge.

The east side of Hinemoa Street from the Bridge Street roundabout to Stewart Street intersection.

All of Stewart Street up to King Street intersection. North of King Street up to Goulstone Road intersection.

All of Goulstone Road up to Valley Road intersection. Valley Road through to Taneatua Road up to no. 397 Taneatua Road.

Out of zone enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received

Applications for out-of-zone enrolments will be processed in the following order of priority:

First Priority Will be given to students who have been accepted for enrolment in a Special Programme/s run by the school and approved by the Secretary for Education: the Bilingual Programme (criteria as attached)

Second Priority Will be given to applicants who are siblings of current students.

Third Priority Will be given to students who are siblings of former students.

Fourth priority Will be given to applicants who are children of board employees.

Fifth priority Will be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Bilingual Programme

Criteria for entry into the bilingual programme

1. The student's whanau must want the child to be in a bilingual class. The school's nomination form will be used for this.
2. Whanau support is expected – in particular, attendance at regular whanau hui
3. Priority will be given to students who have had previous bilingual or Maori medium education.
4. Whanau must support Te Hahi Ringatu for karakia in this class. Students do not attend Bible in Schools.
5. The child must have the potential to achieve our school's achievement benchmarks.
6. The staff must consider that a bi-lingual pathway will benefit the student.
